Context

All schools must provide a curriculum that is broadly based, balanced and meets the needs of all pupils. Under section 78 of the Education Act 2002 and the Academies Act 2010, a PSHE curriculum:

- Promotes the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and
- Prepares pupils at the school for the opportunities, responsibilities and experiences of later life.

PSHE

At The Merton Primary School, we teach Personal, Social, Health Education (PSED) using a whole-school approach. We base our progression upon the Jigsaw scheme of work although teachers have the autonomy to adapt this as they believe is suitable for their class or to reflect issues that occur across the year and need careful reflection or education on. We believe our approach underpins children's development as they begin to understand what personal, social and health education is, how important it is to their physical, mental, emotional development and as a vehicle for our young people to reflect upon as they grow up and develop a sense of self whilst respecting the collective and supporting children's capacity to learn and flourish at school and beyond.

Our school vision weaves, throughout our curriculum, a focus in physical and mental health and the power of collaboration, with these particular threads in mind and of course the statutory sex and relationships coverage that is vital for all children to be well educated and informed in, we have adopted elements of the Jigsaw Programme which offer us the most comprehensive, carefully thought-through scheme of work which brings consistency and progression to our children's learning in this vital curriculum area. It aims to help children to understand how they are developing personally and socially, and explores many of the moral, social and cultural issues children encounter as they grow and develop. We provide our children with opportunities for them to learn about rights and responsibilities and appreciate what it means to be a member of a diverse society. As a UNICEF rights committed school much of this learning links to

UNICEF and specific rights of children both here and in the wider world. Our children are encouraged to develop their sense of self, the part they have to play as a consenting individual and as part of the collective and in playing a positive role in contributing to school life and making a difference to their lives, the community and the wider world.

How we plan and deliver PSHE also supports the “Personal Development” and “Behaviour and Attitude” aspects required by Ofsted, as well as significantly contributing to the school’s Safeguarding and Equality Duties, the Government’s British Values agenda and the SMSC (Spiritual, Moral, Social, Cultural) development opportunities we provide for our children.

Statutory Relationships and Health Education (or Relationships and Sex Education)

“The Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019, made under sections 34 and 35 of the Children and Social Work Act 2017, make Relationships Education compulsory for all pupils receiving primary education”.

The guidance, mirrors our own local safeguarding priority regarding cyber security and our older children’s use and misuse of social media in that it continues to state that: “Today’s children and young people are growing up in an increasingly complex world and living their lives seamlessly on and offline. This presents many positive and exciting opportunities, but also challenges and risks. In this environment, children and young people need to know how to be safe and healthy, and how to manage their academic, personal and social lives in a positive way. Our PSHE policy therefore puts in place the key building blocks of healthy, respectful relationships, focusing on family and friendships, in all contexts, including online and this sits alongside the essential understanding of how to be healthy.”

This policy when read alongside our Social, Emotional and Mental Health Policy shows how our PSHE curriculum supports the wellbeing of our children as they adapt to the modern world. “These subjects represent a huge opportunity to help our children and young people develop. The knowledge and attributes gained will support their own, and others’ wellbeing and attainment and help young people to become successful and happy adults who make a meaningful contribution to society.”

The DfE guidance states the following: “Schools are free to determine how to deliver the content set out in the DfE guidance 2019 in the context of a broad and balanced curriculum”. By following the Jigsaw program of study we ensure that effective teaching of RSE, Internet safety and healthy relationships is happening weekly and will ensure that the key knowledge is broken down into units of a manageable size and taught to children clearly, carefully and in a well sequenced way, within a carefully planned programme of lessons.

The DfE set out that **“All schools must have in place a written policy for Relationships Education and RSE”**. Therefore We include the statutory Relationships and Health Education within our whole-school PSHE Programme.

Here, at the Merton Primary School we understand the importance of ‘getting’ this area of the curriculum right’ to ensure children are in a happy place to learn and are equipped with age appropriate knowledge. We do this through our vision, ethos and carefully mapped PSHE provision. We endeavour to enable children to understand and respect who they are, to understand that they have the right to consent and to understand their place in the world. We respond to and empower children through pupil voice and therefore equip them for life and learning in this ever changing world.

To ensure progression and a spiral curriculum (at the discretion of the Teacher certain topics may be taught cohesively with other areas of the curriculum), we use Jigsaw, the mindful approach to PSHE, as our chosen teaching and learning programme and tailor it to your children’s needs. The mapping document: Jigsaw 3-11 and statutory Relationships and Health Education, shows exactly how Jigsaw and therefore our school, meets the statutory Relationships and Health Education requirements.

This programme's complimentary updated policy ensures we are always using the most up to date teaching materials and that our teachers are well-supported.

What do we teach when and who teaches it?

Whole-school approach

Jigsaw covers all areas of PSHE for the primary phase including statutory Relationships and Health Education. The table below gives the learning theme of each of the six Puzzles (units) and these are taught across the school; the learning deepens and broadens every year.

Term	Puzzle (Unit)	Content
Autumn 1:	Being Me in My World	Includes understanding my own identity and how I fit well in the class, school and global community. Jigsaw Charter established.
Autumn 2:	Celebrating Difference	Includes anti-bullying (cyber and homophobic bullying included) and understanding
Spring 1:	Dreams and Goals	Includes goal-setting, aspirations, who do I want to become and what would I like to do for work and to contribute to society
Spring 2:	Healthy Me	Includes drugs and alcohol education, self-esteem and confidence as well as healthy lifestyle choices, sleep, nutrition, rest and exercise
Summer 1:	Relationships	Includes understanding friendship, family and other relationships, conflict resolution and communication skills, bereavement and loss
Summer 2:	Changing Me	Includes Relationships and Sex Education in the context of coping positively with change

At The Merton Primary School we allocate 30-60 minutes to PSHE each week in order to teach the PSHE knowledge and skills in a developmental and age-appropriate way.

These explicit lessons are reinforced and enhanced in many ways:

Assemblies, themed weeks, Learning Charter, through relationships peer to peer, adult to child and adult to adult across the school. We aim to 'live' what is learnt and apply it to everyday situations in the school community.

Class teachers deliver the weekly lessons to their own classes.

Relationships Education

What does the DfE statutory guidance on Relationships Education expect children to know by the time they leave primary school?

Relationships Education in primary schools will cover 'Families and people who care for me', 'Caring friendships', 'Respectful relationships', 'Online relationships', and 'Being safe'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Relationships Puzzle (unit) in Jigsaw covers most of the statutory Relationships Education, some of the outcomes are also taught elsewhere in Jigsaw e.g. the Celebrating Difference Puzzle helps children appreciate that there are many types of family composition and that each is important to the children involved. This holistic approach ensures the learning is reinforced through the year and across the curriculum.

Health Education

What does the DfE statutory guidance on Health Education expect children to know by the time they leave primary school?

Health Education in primary schools will cover 'Mental wellbeing', 'Internet safety and harms', 'Physical health and fitness', 'Healthy eating', 'Drugs, alcohol and tobacco', 'Health and prevention', 'Basic First Aid', 'Changing adolescent body'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Healthy Me Puzzle (unit) in Jigsaw covers most of the statutory Health Education, some of the outcomes are taught elsewhere in Jigsaw e.g. emotional and mental health is nurtured every lesson through the Calm me time, social skills are grown every lesson through the Connect us activity and respect is enhanced through the use of the Jigsaw Charter.

Also, teaching children about puberty is now a statutory requirement which sits within the Health Education part of the DfE guidance within the 'Changing adolescent body' strand, and in Jigsaw this is taught as part of the Changing Me Puzzle (unit).

Sex Education

The DfE Guidance 2019 (p.23) recommends that all primary schools 'have a sex education programme tailored to the age and the physical and emotional maturity of the pupils'.

However, 'Sex Education is not compulsory in primary schools'. (p. 23)

Schools are to determine the content of sex education at primary school. Sex education 'should ensure that both boys and girls are prepared for the changes that adolescence brings and – drawing on knowledge of the human life cycle set out in the national curriculum for science - how a baby is conceived and born'.

At The Merton Primary School, we believe children should understand the facts about human reproduction before they leave primary school.

Primary sex education will focus on:

- Sexual differences and naming body parts.
- Preparing pupils for the changes that adolescence brings.
- Exploring the impact of puberty on the body and the importance of personal hygiene.
- How a baby is conceived and delivered.
- Answering each others' questions about sex and relationships with confidence and knowing where to find support and advice.

We intend to teach this through PSHE lesson, however it will also be taught naturally in other areas such as science and RE.

As part of our PSHE curriculum, children will be taught about strong and mutually supportive relationships, both in and outside of marriage. This will include heterosexual or same sex relationships. These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

We aim to provide accurate information and to help to develop skills in empathy, understanding difference, and respect for themselves and others. We hope to develop citizens who will prevent and remove prejudice.

Parents' right to request their child be excused from Sex Education

Parents **do not** have the right to withdraw their children from relationships education taught through the Science Curriculum.

Parents **do have** the right to withdraw their children from the non-statutory components of sex education within PSHE.

Requests for withdrawal should be made in writing to the Head Teacher during the Spring Term. Alternative work will be given to pupils who are withdrawn from sex education.

At The Merton Primary School, puberty is taught as a statutory requirement of Health Education and covered by our Jigsaw PSHE Programme in the 'Changing Me' Puzzle (unit). We conclude that sex education refers to Human Reproduction, and therefore inform parents of their right to request their child be withdrawn from the PSHE lessons that explicitly teach this i.e. the Jigsaw Changing Me Puzzle (unit) e.g.

Year 4, Lesson 2 (Having a baby)

Year 5, Lesson 4 (Conception)

Year 6, Lesson 3 (Conception, birth)

The school will inform parents of the curriculum content by letter and PSHE Knowledge Organisers towards the end of the term before the unit Changing Me Puzzle is taught.

Monitoring and Review

The governing body monitors this policy on an annual basis and where necessary will modification the policy. The governing body gives serious consideration to any comments from parents about the PSHE programme, and makes a record of all such comments. Governors scrutinise and ratify teaching materials to check they are in accordance with the school's ethos.

Equality

This policy will inform the school's Equalities Plan.

The DfE Guidance 2019 (p. 15) states, "Schools should ensure that the needs of all pupils are appropriately met, and that all pupils understand the importance of equality and respect. Schools must ensure they comply with the relevant provisions of the Equality Act 2010 under which sexual orientation and gender reassignment are amongst the protected characteristics..."

At the point at which schools consider it appropriate to teach their pupils about LGBT (Lesbian, Gay, Bisexual, Transgender), they should ensure this content is fully integrated into their programmes of study for this area of the curriculum rather than delivered as a stand-alone unit or lesson. Schools are free to determine how they do this, and we expect all pupils to have been taught LGBT content at a timely point as part of this area of the curriculum".

At The Merton Primary School we promote respect for all and value every individual child. We also respect the right of our children, their families and our staff, to hold beliefs, religious or otherwise, and understand that sometimes these may be in tension with our approach to some aspects of Relationships, Health and Sex Education.

Relationships Education in Primary schools (Appendix) – DfE Guidance 2019

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults. The references R3/H5 etc can be cross-referenced on the Jigsaw mapping documents and Puzzle Maps to show which lessons throughout Jigsaw contribute to which statutory outcomes. All statutory outcomes are covered in the Jigsaw 3-11 Programme.

The guidance states that, by the end of primary school:

Physical health and mental well-being education in Primary schools – DfE Guidance

The focus in primary school should be on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental well-being is a normal part of daily life, in the same way as physical health.

By the end of primary school:
